Dr Jo Doran is a doctor with over 30 years' experience in palliative care. Jo currently works for Gold Coast Hospital and Health Service as a senior consultant.




She has been involved in policy development and implementation on local, state and national levels. She is passionate about education in end-of-life care and is highly regarded as a guest speaker and MC.

Her contributions to the field of Exercise Physiology have been acknowledged by Exercise and Sports Science Australia (ESSA). In 2021, Caoimhe was awarded Accredited Exercise Physiologist of the Year and recognised as a Female Leader in Exercise & Sports Science by ESSA.

Dr Lawrie Palmer, Palliative Medicine Specialist, Modbury Hospital Panel Discussion

Dr Lawrie Palmer is a Palliative Medicine Specialist at Modbury Hospital and formerly Medical Head of Unit for Northern Adelaide Palliative Service.

Dr Edward Mantle is a Staff Specialist in Palliative Medicine at Gold Coast Hospital & Health Service. His career commenced in Canada where he developed a keen interest in Continuous Ambulatory Delivery Device (CADD) plus patient-controlled analgesia (PCA).

Upon moving to Australia in 2012 he became the Clinical Lead/Director of the Palliative Medicine Service for the Cairns Hinterland Hospital Health Service. He developed and introduced procedures and prescribing materials for CADD plus PCA and has promoted their use for pain management in palliative care settings. During his time in Cairns as both Clinical Lead and Clinical Director he was part of a dedicated interdisciplinary team developing six domains of service across the Region including in-reach and outreach services to Residential Aged Care Facilities and Rural and Remote regions.
